## 2. Course Innovations

In my course “Issues in Writing Research: The Social Justice Turn in Technical and Professional Communication,” I collaborated with students to create an open-access annotated bibliography focused on the social justice turn in technical and professional communication. This bibliography was circulated on technical and professional communication listservs and was intended to be a resource to support the continued interest of social justice and technical communication. The annotated bibliography was originally hosted on the Writing & Rhetoric MKE blog/website that my colleague, Dr. Rachel Bloom-Pojar, has since deactivated. The annotated bibliography remains an open-access resource available here: <https://dc.uwm.edu/writingmke/5/>.

Frequently, I reflect with my graduate students on the experiential learning that occurred in my graduate seminar courses. One publication and one publication in



progress has resulted from this collaborative reflection. For instance, in my “Theories in Public Rhetoric and Community Engagement: Cultural Rhetorics” course, I co-authored with students a course design that made explicit the connections students made between cultural rhetorics and community engagement. That course design was published in *Composition Studies*, 49(1), and can be found here: <https://files.eric.ed.gov/fulltext/EJ1307793.pdf>. Another publication is in progress with students enrolled in my “Seminar in College Writing Pedagogy: Community Literacies & Writing” and discusses our engagement with new issues in prison literacy.

All of my undergraduate/graduate combined courses (i.e., Technical Editing, Grant Writing, and Writing for Nonprofits) are designed as service-learning courses where students work collaboratively in teams with local non-profits to support their writing needs. Examples of local non-profits students have supported include: Walker’s Point Youth and Family Center, Reflo, Friends of Lakeshore Park, The Community, 5Points Neighborhood Association, Center for Leadership of Afrikan Women’s Wellness, and ImagineMKE to name a few. Students are provided “real world” opportunities to apply writing to local and community organizational needs; and in return, organizations receive materials and support to facilitate changemaking in Milwaukee and the surrounding community.

At the University of Wisconsin-Oshkosh, I designed and successfully oversaw the curricular approval for the 21-credit Professional Writing minor. I not only advised colleagues on best practices in teaching professional writing but also offered professional development workshops on courses in the professional writing program to train English faculty instructors to teach in the minor.
